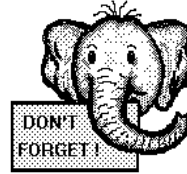

BOARD & GENERAL MEETING MINUTES AND HIGHLIGHTS

The TLS Board met on January 8, 2020 at 7:30 p.m. at the TLS Education Center in Brookhaven. The minutes of the December 2019 Board Meeting were approved as distributed as was the Treasurer's report, which included the December balance sheet and transaction report.

Announcements: Member Steve Hansen has attained the level of "Master" in the U. S. Faceter's Guild and received second prize for his entry. We congratulate Steve on his success.

Treasurer's Report:

The 2020 Draft Budget submitted by Frank Warner was approved as distributed. Dues are still being collected. Those members who have not yet paid their dues may not register for classes at member rates. A fourth and final Mailchimp notice will go to those people. Those not paid by February 15 will be dropped from the roster. On Frank's recommendation, the Board approved a bonus to Christine Bowen, who cleans the Education Center.

Committee Reports:

Membership: Stacey Segal presented an application from Mary Beth Nardy, which was unanimously approved by the Board. The Board also unanimously agreed on motions to reinstate membership to former member Bernie Fallon and to give permanent newsletter-only membership status to Cindy Duncan.

Education: Kathy Hobson is asking for ideas for Spring classes. The Beginner and Intermediate Silver classes are full, as are Opal Cutting, Faceting, and the daytime Beginning Cab session.

Education Center: John Chickadel and Pete Santucci filed our annual report on recycling with the Borough of Brookhaven.

Equipment and Facilities: Don Schwarzkopf reported that the saw is fixed. The leak was at the hinge. He changed the oil on all saws.

Library and eBay: Stacey Segal reported that old wheels were cleaned and offered on eBay, as well as some books. She will check the outstanding cards and check for books that need to be returned. Frank Warner presented the Library with a new volume (#20 in the set) from Lithographie LTD, Rubilite, Tourmaline Rouge.

New Business: Member Ken Dahl has agreed to take the Treasurer's position in a year. The Board approved the motion to make Ken the Assistant Treasurer during the transition period.

In Frank's absence, Linda reported that an audit of the financial records will be done in March. Members Joyce Babiarz, Teresa Fain, and Ken Dahl as well as the President and Vice President will be invited to participate.

Linda Green reported that Lisa Laffend will be the Education Chair. Lisa reported that the Delaware County Arts Consortium will continue to use the www.DelcoArts.org website calendar for events throughout the year, and will post events such as Gemarama, General Meetings and Classes there. Another open house is being considered during Delco Arts Week this year.

Steve Hansen said Kieu Pham Gray is teaching this weekend. Main Line School Night registration is now open for our May and June weekend cabochon workshops. Jeff Fulkerson will teach three days in June—two days of "rings" and one day of general silversmithing.



The General Meeting was held Wednesday, January 15. Committee reports and other items discussed at the Board Meeting were presented.

Linda Green announced the passing on January 9, 2020 of member J. Shipley Newlin at the age of 108.

Linda announced that Steve Hansen has attained the level of "Master" in the U. S. Faceters Guild and received second prize for his entry.

In Frank's absence, Linda said that finances are strong. There are still a few members who owe dues. The names of those not paid by February 15 will be dropped from the roster.

The 2020 budget was approved at the January Board meeting. An audit of the financial records will commence in March. Also approved was the appointment of Ken Dahl as Assistant Treasurer.

Rick Hellman announced the evening's program by Ken Dahl on Rockhounding on the Upper Peninsula of Michigan. Programs for February, April and May General Meetings are yet to be determined, and March will be the Silent Auction.

Lisa Laffend will be the Education Chair. Lisa reports Delco Arts Week will be the first week of October. TLS events and classes will be listed on their calendar.

John Chickadel had the fire extinguishers inspected last week. Don Schwarzkopf reported that all machines in the saw room were cleaned and serviced with fresh oil. All saws are in working order.

Steve Hansen reported that the classes held by Kieu Pham Gray were successful and attended by 40+ people. He thanks all who assisted in the classes. Jeff Fulkerson will teach 3 days in June—two days of rings and one day of silversmithing.

The program was an interesting presentation by Ken Dahl about rock and mineral collecting in the Upper Peninsula of Michigan, the location of many closed copper mines. He also provided samples and pictures of copper nuggets, assorted agates, tourmalines and other minerals.

He was a Master in Cabochons in our SKIP program. He taught metal shaping classes using many tools that he created himself. She was an apprentice in cabbing and faceting in our SKIP program. She gave our earliest bead making workshop at our former Jasper Street

address using propane torches held by hand. Ruth died in 2007.

PRESENTATION FOR THE TLS GENERAL MEETING FEBRUARY 12, 2020

The Opals of Australia-A Documentary by Patrick Voillot

Our February Special Presentation will be a very informative and entertaining documentary of the discovery of opals in the Australian Outback and the evolution of the opal industry over the ensuing 100+ years. This documentary incorporates a discussion of the structural nature of opal that gives rise to its spectacular brilliance, and the challenges presented to the miners who seek these gemstones of the Outback. Included is a discussion of opalized fossils, particularly the opalized bones of ancient marine reptiles (pliosaurus and plesiosaurs) and of dinosaurs, and current thoughts of how, through the replacement of calcium carbonate by precious opal, such magnificent fossils were created. I will bring examples of some opalized fossils derived from the Coober Pedy fields of Australia, both belemnites and mollusks (cockles and bivalves), to be presented after the documentary for your viewing pleasure.

TLS MEETING/CLASS CANCELLATION SYSTEM

If an evening meeting or class at the TLS Education Center or a General Meeting is canceled due to inclement weather, an appropriate message will be put on the Center's voice-mail system by 4 p.m. that day. So, if you have concerns regarding any evening event, call the Center at 610-490-5252 after 4pm and listen to the message. In addition, both daytime and evening instructors have the authority to cancel a class due to inclement weather at their discretion. Should this scenario occur, all affected students will be

called by the respective instructor and, if possible, a message will be placed on the Center's voice-mail system.

If a General Meeting is canceled or an emergency or other circumstance requiring special attention occurs, the TLS Phone Tree (page 7) and email-alert system will be activated.



INSTRUCTOR BENEFIT

It is TLS policy that TLS members who teach a regular course (fall, winter, spring, or summer) or a substantial workshop may, within the following twelve months, take a regular class or workshop without paying the normal member tuition. Any special course fees or materials fees in excess of tuition must be paid by the instructor.

Instructors who wish to take advantage of this benefit must advise the Registrar of the specific course or workshop for which they would like to use the benefit.

A TLS member who supervises an Open Shop session, other than Open Slab Saw, may, at no cost, be a participant in that Open session. A TLS member who supervises five hours of Open Slab Saw may use the slab saws for one hour free as long as at least one other person certified in Slab Saw is present, as required by the TLS Safety Rules.

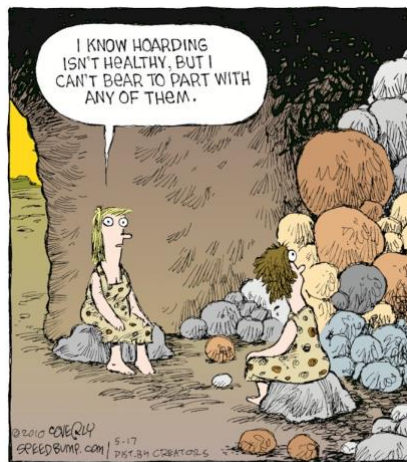

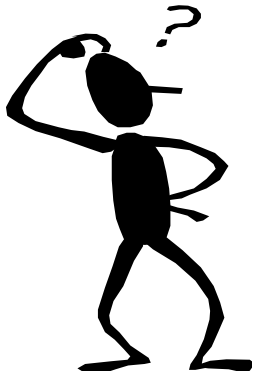
