<u>Treasurer's Report</u>: Ken Dahl reported cash inflow and outflow for the month of March showed a positive total. Tax returns have been filed for 2021.

The various organizations discussed future programs. <u>Programs</u>: Gary Cummings reported on behalf of Kathy Lopez on the upcoming programs. JUNE DINNER SINGLE STONE EXHIBITION

Our June dinner will be here before you know it! It's time to submit a cabochon or faceted gem (or one of each) for the Single Stone Exhibition. Any color, shape, or style is welcome. The submissions are evaluated solely on the merits of YOUR work; a number is submitted with your entry instead of your name, and you will be given individualized written feedback on your demonstrated skill and the quality of your work. No one sees the evaluation but you.

These cabochons or faceted gems can later be submitted to the SKIP program as well. Further information about SKIP appears on page 5 of this Bulletin.

To submit your cab, put it in a baggie labeled with your name and the name of the stone (picture jasper, red agate). Faceted gems should be placed in an appropriate container before being placed in a baggie; be sure to label it clearly and include the diagram used to cut the gem. The collection point is a plastic container in the lower right-hand drawer of the desk in the library at the Ed Center. Numbers will be assigned before the judges see them so they don't know who they are evaluating.

TLS History Series #18 Highlights, Part 6: 1996 - 2007

1996

A Long-Range Planning Committee, headed by Roger Binns, began looking for a possible new home for the TLS Skill Center. TLS began this year with a balance of \$85,583.44.

1997

The 50th anniversary celebration of the American Federation of Mineralogical Societies (AFMS) was in October. Barbara Jacobsen's case received a perfect 100 point score and the AFMS trophy. The *Bulletin* won the EFMLS trophy for small bulletins. Plans were made to move Gemarama to The School at Church Farm in 1998.

1998

Lapidabrade (a lapidary supply store in Havertown) closed June 26. Good friends Lucy and Charles Hamilton retired. The Long Range Planning Committee looked at many possibilities, but reported in November that it felt the Society could not afford to purchase an existing building, but could possibly purchase an open lot and erect a prefabricated building.

1999

A written and pictorial history project was started. The 25-year history prepared in 1982 could not be found. The Education Committee was established.

2000

Associate fees for 10-week classes were raised from \$70 to \$95. TLS Member and Auxiliary fees for 10-week classes were raised from \$10 to \$25. Discounts were adopted for shorter courses or for those members or auxiliaries taking multiple courses in the same term. The first of two backups of the building's sewage system occurred in May.

2001

The Liberty Bell Intarsia was finally completed. Chesna Coren died 3/17/01. A "newsletter only" category at \$10 per year was created for former members who wished to continue receiving the *Bulletin*.

2002

Long-time Gemarama dealer Ron Martin died on March 24. A surprise party for Al Webber's 95th birthday was held at the General Meeting in October.

2003

An article by Frank Warner on the Liberty Bell Intarsia project appeared in the July issue of *Lapidary Journal*. TLS accepted an invitation to have a demonstration booth at the Lebanon show in August.

2004

The second and more serious sewage backup in the Skill Center occurred over the year-end holiday break of 2003-04. Winter term classes were delayed a week while the Skill Center was cleaned. This gave additional impetus to the search for a "A Skill Center of Our Own" that had been started again by

the Board a few months earlier. Potential sites were identified and visited over the winter and spring of 2004. In early April the Society's cash assets totaled \$144,105.52. By summer, it was clear that the Society would need to raise a substantial New Home Fund in order to be able to take advantage of any outstanding opportunities. A special insert in the September Bulletin alerted members that there would be an important discussion of the New Home search at the September meeting. As that Bulletin was going to press, the Society was invited by the Board of Directors of the Community Arts Center (CAC) in nearby Wallingford to consider an association in which TLS would contribute to the construction of a new wing of the arts center and, in return, receive the right to rent substantial space in the new wing on a long-term basis. The proposed association with the CAC was approved by the membership in late 2004. Contributions to the New Home Fund by members totaled \$37,000 in 2004.

2005

A letter of intent was signed with the CAC. Floor and electrical plans were developed with Architect Jon Sutton. New Home Fund contributions for the year were \$45,200.

2006

Guest instructor Joan Strott-Alvini gave her first enameling workshop at TLS. Dues were increased to \$30 per member, \$45 per member couple, \$15 for a spouse as an Auxiliary member, and \$15 for those in the "newsletter only' category. Details of the proposed association with the Community Arts Center changed in time. It was decided that it was in the best interest of TLS to resume the search for a Skill Center site of our own. TLS ended the year with a balance of \$276,467.41 including at least \$134,458.02 in the New Home Fund.

2007

TLS began participating in Media Second-Saturday events to go from being "the best-kept secret in Media" to becoming a well-known part of the community. On the first night, 83 adults, 37 children, and a beagle stopped by.

A 50th Anniversary Celebration and Annual Awards Dinner was held June 13 at the Lamb Tavern in Springfield with over 100 members and guests attending. The program included a slide-show retrospective of the first 50 years, the distribution of a 40-page history booklet 1957 – 2007, and the viewing of a 50th anniversary photo album and scrap book. It was a very special celebration.

TLS purchased a digital projector and laptop computer. The building in which TLS was renting space for the Skill Center was sold. A one-year lease was secured from the new owners. The possibility of locating the Skill Center in a retirement community, Whiteland Village, to be built near the School at Church Farm was discussed. A magnificent donation of equipment and supplies from Al and JoAnn Siegfried was stored in a climate-controlled locker facility in Exton. Al Webber celebrated his 100th birthday at the TLS General Meeting on October 10. An application for PA sales tax exemption was filed in July. The application was initially denied on the basis that we do not "relieve the government of some of its burden."

The Tuscarora Lapidary Society (TLS) is a 501(c)(3) non-profit corporation and a Pennsylvania Purely Public Charity organized to encourage and teach the science and art of lapidary (the cutting and polishing of stones) as well as the arts and sciences associated with lapidary interests.
